The Challenge: A Growing Epidemic

Across our great nation — from the foggy streets of San Francisco to the bright lights of New York City — homelessness is becoming an epidemic that we can no longer afford to ignore. According to a report issued by the White House in September 2019:

Over half a million people go homeless on a single night in the United States. Approximately 65 percent are found in homeless shelters, and the other 35 percent — just under 200,000 — are found unsheltered on our streets (in places not intended for human habitation, such as sidewalks, parks, cars, or abandoned buildings). Homelessness almost always involves people facing desperate situations and extreme hardship. They must make choices among very limited options, often in the context of extreme duress, substance abuse disorders, untreated mental illness, or unintended consequences from well-intentioned policies.¹

- Prepares and submits all initial applications and continuing disability reviews, and advocates for benefits eligibility throughout the life of the case until a favorable decision is obtained, including all levels of appeals and hearings
- Leverages federal benefits to reduce financial burdens on state and local governments
- Assists individuals with gaining access to Medicaid, enabling them to receive care from a primary provider instead of relying on emergency services
